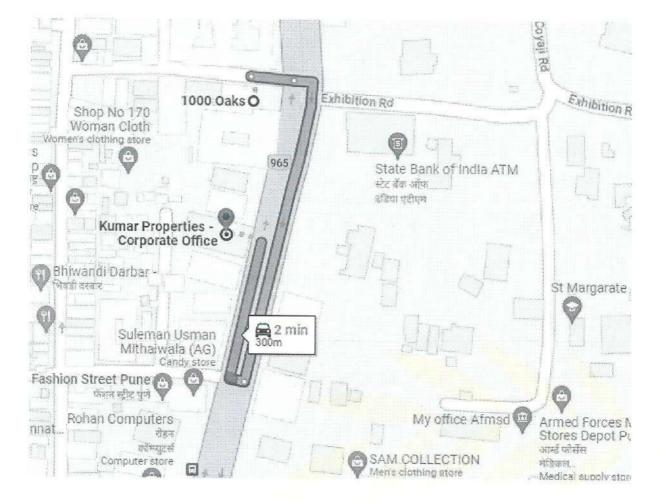


# ROUTE MAP FOR THE 26<sup>TH</sup> ANNUAL GENERAL MEETING OF THE COMPANY
